Jessica A. Chase, date of birth [REDACTED], was a Public Administrator (PA) in [REDACTED], Missouri from January 3, 2021, until her resignation on February 6, 2024. During Chase's tenure as PA, she served as the Conservator for many elderly and/or disabled persons in [REDACTED]. While conducting her duties as PA, Chase financially exploited and permanently deprived several elderly and/or disabled persons of their money by utilizing the funds from their accounts, without their knowledge or permission, to purchase personal items for herself. Chase also withdrew cash from several bank accounts which she was Conservator of, without their knowledge or permission, and kept it for herself. All the transactions and cash withdrawals were falsely documented on the Individual's financial statements. Chase conducted the following deceitful transactions and cash withdrawals between March 16, 2023 – December 22, 2023:
